Blue Ridge Fuel Reduction Cal-Fire California Climate Investment/Fire


Prevention Program



Blue Ridge is a key ridgeline separating the communities of Three Rivers, Happy Camp, Springville, Mountain Home Forest and numerous ranch homes.

This project aids in protecting approximately 5,000 homes.

Treating 100 acres along a portion of the Grouse Fire Control road and a portion of the Blue Ridge Road with hand crews and masticator treatment 200' from each side of the road.
