dying conifer tree within your 100 foot defensible space caused by the bark beetle or drought.

### FOREST FIRE PREVENTION PROJECTS

Sequoia Crest Fuel Reduction Project -75 Acres

Cal-Fire California Climate Investment/Fire Prevention Program



Sequoia Crest is a community of over 100 homes located approximately 12 air miles east of Springville at an elevation of 7,000'. The majority of the 140-acre development is divided into lots approximately 1/3 acre in size and was originally part of the 640-acre parcel owned by the Rouch family.



The community is surrounded by the giant Sequoia National Monument. Approximately 75 acres around the community have received fuel treatments in the last two years. This project proposes to expand upon that work and treat another 75 acres through a combination of hand crews, chipping and mastication.
