## **NEW BUSINESS:**

**Local Working Group:** We are keeping in touch with Aaron Fukada, manager of Tulare Irrigation District, to get a meeting date with the whole district for our LWG activity this year.

**Cal-Fire applications:** We will hear about awards probably in July.

## **CURRENT PROJECT UPDATES:**

**Cal-Fire Fuel Break projects (Clearances, Ward Canyon, Direct Award, Whisset)** – Bob Bob reports he is seeing some projects that will need road work.

Cal-Fire Fuel Break projects (Ponderosa) – David / Jeff

Jeff reports work will start in early July. He will be back from Mexico soon.

**Case Mountain, BLM project:** Jack Thornburg has his largest equipment to move humungous amounts of dirt to fill and repair the washed out roads -11 miles of them. It takes a quad to get into the area right now. Jeff and David will be doing plant surveys this summer.

**Sequoia National Forest:** The stewardship agreement has been finalized and signed. Four of the five projects in this agreement complement and are in the same area as our Cal-Fire projects.

**SGMA**: Kaweah GSA maintains the rules are going to change just because there was so much rain and flooding has occurred. Farmers can file an application for \$500 for re-charge and get an 80% credit. Tule Lake is 4 to 6' deep, and in some places 22' deep.

**CARCD RCPP:** Antonia is having difficulties finding PCAs unwilling to do weed treatments in the forest. The NRCS Area 3 forester says he can certify properties with the County permits.
